

Draw Terms and Conditions

Conditions of entry

1. This draw is open to residents of the UK aged 18 years or over. Employees of UK Gift Card & Voucher Association (UKGCVA), agents or anyone else professionally associated with the draw are not eligible to enter.
 2. Details of how to enter form part of these terms and conditions. It is a condition of entry set out by these terms and conditions that the entrant agrees to abide by them. The outcome of the draw is final, and the UKGCVA reserves the right not to enter into correspondence regarding disputes.
 3. Entrants to this draw must:
 - Use #GiftBetter in an Instagram post or comment on an Instagram post from @GiftBetterUK
- OR
- Retweet the @GiftBetter competition tweet using #GiftBetter
- OR
- Comment with #Giftbetter on the competition Facebook post from the @GiftBetterUK page to enter.
 - Entrants must “like” or “follow” the GCVA on their chosen channel to be eligible for the draw. Entries cannot be amended in any way after submission or may be deemed ineligible.
4. All entries will be accepted for the duration of the draw period. The draw period is defined as being from the exact time the post appears until 23:59 the same day.
 5. Entries must be made before midnight on the day of the draw period to be deemed valid. The Gift Cards are provided by member partners of the GCVA.
 6. Should any gift card become unavailable, GCVA reserves the right to provide a substitute gift card of equal value.
 7. Winners will be drawn at random during the draw period from all entries received during such time.
 8. Gift Card recipients will be contacted via social media from the GCVA’s #GiftBetter, Facebook, Twitter and/or Instagram account. If the GCVA doesn’t receive a response from the winner within 48 hours the GCVA reserves the right to award the gift card to an alternative entrant, drawn in accordance with these terms and conditions.

NB. If you are entering on Facebook, your account must allow for message requests from GiftBetter on all social platforms. This can be toggled in your 'Privacy and Safety' settings in messenger.

9. The Gift Cards provided are non-transferable. There are no cash alternatives.

10. The Gift Cards can be spent in accordance with their terms and conditions of use. The GCVA is not responsible for the terms of use of a gift card issued by an organisation or any communications they may provide. Any questions regarding the card must be referred directly to the issuing partner.

11. Recipients will be sent their Gift Card within 7 days of accepting the Gift card if sent via post or within 48 hours if via email. The GCVA cannot be held responsible for postal delays during the festive period.

14. The gift card you receive may differ from the image as seen on Facebook, Instagram or Twitter, but the value will remain the same.

By entering into the #Giftbetter draw, the entrant agrees that should they be selected to receive a Gift Card, the GCVA and the Gift Card issuing partner of the GCVA, may publish their name across their respective Facebook, Instagram and Twitter platforms.
